LSA 2024 Pre Conference Workshop

This year, Law and Society Association is bringing their conference to Denver in June! Before the conference begins, we'll have an opportunity for local organizers to do a half day presentation for the researchers about our community work and legislative advocacy on June 5th. We'll be bringing members of our regional coalition together in Denver from across several groups and locations to present and attend the conference including several of our Pueblo organizers who do the weekly p.m.gran.te drop ins, Rouge Support Network members traveling both in state from Fort Collins and nationally from NYC, and community partners from organizations in Boulder.

We'll be renting a SW owned venue for the occasion and since the timing coincides closely with June 2nd which is our annual observance of International Whores Day we'll be transitioning from the Day of Dialogue into an open community event in the evening while we have so many of our CO community gathered in the same place for this special occasion! International Whores Day commemorates the occupation of a church in Lyon in 1975 by workers protesting legal crackdowns that were forcing their work increasingly underground and making them more vulnerable to violence from the police, issues that have been snowballing for us in the US since the passage of SESTA/FOSTA as well. We do most of our community work on shoestring budgets run almost entirely by unpaid current/former SW volunteers and/or multiply marginalized current/former workers receiving supplemental income stipends and we no longer have a permanent community space located in Denver, so we'd like to request support in raising funds to cover:

- A 1,000 day rate for the venue rental
- Travel expenses, meals, and lodging for organizers traveling to present at the Day of Dialogue and attend the LSA conference
- Stipends for event presenters, performers, and organizers
- Non-alcoholic refreshments, food, and gift bags to provide to event organizers and guests

Any excess funds raised will be shared among our regional coalition member orgs.

Whore's Eye View & Additional Sex Work Panels During LSA 2024

Whore's Eye View (6/7 5pm, 6/8 8:45pm, 6/9 7pm)

Whore's Eye View is a mad dash through 10,000 years of history from a sex worker's perspective. Weaving history, comedic storytelling, and the wisdom of lived experience, Kaytlin Bailey artfully unpacks the complex, age-old stigma of the oldest profession, underpinning a status quo designed to keep women in their place. Whore's Eye View is a very personal story. It's also a call to action that in order to achieve the decriminalization of sex work, we must change the stories we are telling about the oldest profession.

Kaytlin Bailey, writer & performer: Kaytlin Bailey is a globally recognized leader in the sex worker rights movement, quoted in The New York Times, Rolling Stone, The Washington Post, The Boston Globe, The Village Voice, The Nation, NBC, and ABC. She has written op-eds for Huffington Post, Reason, The Daily Beast, and Vice, and has spoken at Fox Business, Yale Law School, Penn University, and UCLA. Kaytlin Bailey hosts The Oldest Profession Podcast, where each episode focuses on an "old pro" from history, contextualizing that figure in their own time and connecting their story to the ongoing struggle for sex worker rights. She founded Old Pros, a non profit media organization creating conditions to change the status of sex workers in society.

Call for Papers: Exploring Media Representations of Human Trafficking
Editor: Menaka Raguparan, PhD; University of North Carolina Wilmington

I invite scholars, activists, and practitioners to contribute to a groundbreaking volume on *Human Trafficking in Mass Media: (Mis)Representations, Sensationalization, and Implications*, currently under consideration with Palgrave Publishing for their esteemed Crime and Media series.

Human trafficking, a hot-button public debate and policy issue, is frequently sensationalized and misrepresented in mass media. Media coverage often distorts realities and influences public perception. This edited collection seeks to critically examine the multifaceted role of media in shaping narratives surrounding human trafficking, locally and internationally.

Drawing on the framework outlined by Austin and Feral (2017), which identifies three primary framing strategies employed by the media—Diagnostic, Prognostic, and Motivational—this volume aims to dissect and analyze how these frames contribute to the construction and perpetuation of specific narratives surrounding human trafficking.

I invite contributions that explore a wide range of topics, including but not limited to:

- Analyzing media representations of human trafficking and their impact on public perception and policy formulation.
- Examining the intersectionality of race, gender, and class in media depictions of human trafficking victims and perpetrators.
- Investigating the role of digital media and social networking platforms in disseminating information and shaping narratives about human trafficking.
- Exploring the ethical implications of media coverage of human trafficking, including issues of sensationalism, victimization, and survivor empowerment.
- Examining the influence of popular culture, including films, television shows, and literature, on shaping public attitudes and understanding of human trafficking.

I welcome interdisciplinary and decolonial approaches and encourage submissions from scholars across fields such as media studies, sociology, criminology, gender studies, anthropology, law, and beyond. Additionally, I seek contributions that offer empirical research, theoretical insights, case studies, activist perspectives, and policy analyses.

Palgrave Publishing has expressed keen interest in publishing this timely and impactful collection, which aims to contribute to scholarly discourse, inform public understanding, and advocate for more ethical and nuanced media representations of human trafficking.

Please submit abstracts of 300–500 words, along with a brief author biography, to raguparanm@uncw.edu by June 30th, 2024. I look forward to receiving your contributions and engaging in critical dialogue on this crucial issue.
