## **Virtual Conference Call For Proposals "Migrant Health: Risk Communication and Protection against Discrimination During Health Crises"**

**Virtual Conference on "Migrant Health: Risk Communication and Protection against Discrimination During Health Crises", 19–20 October 2023.**

The conference is supported by EUGLOHRIA (The European University Alliance for Global Health – Transformation through Joint Research and Innovation Action, <https://www.eugloh.eu/research/euglohria>) and organized by Pettenkofer School of Public Health (Germany), LMU Munich (Germany), University of Porto (Portugal) and Lund University (Sweden).

The aim of this conference is to exchange experiences on risk communication with migrants and refugees during the COVID-19 pandemic, to discuss effective strategies for combating stigma and discrimination during global health crises, and to assist researchers working on migrant health, risk communication, and anti-discrimination in connecting with one another and planning future collaborations.

Two panels will be held during the conference. The first panel, "Leaving No One Behind in Post-pandemic Societies," will shed light on the health of migrants and refugees within the context of structural vulnerability and social resilience. The second panel will look at stigma and discrimination against vulnerable groups during global health crises, identify lessons learned from the COVID-19 pandemic, and address strategies for preventing stigma and discrimination. Names of speakers and moderators will be announced soon.

Abstracts are invited for oral presentations and project ideas. Oral presentations can be of the following types: original research study, literature review, case report, policy and practice report, curriculum development. Project ideas will be presented as posters.
